The planned work comprises rebuilding and partly extending a subsidence-damaged lean-to extension to a barn some 25m to the east of the house. The eastern walls of the building form part of the boundary between Trevarth House and a field of Trevarth Farm. The current lean-to structure is irregularly shaped and the low roof height of the southern end renders it almost unusable. The essential rebuilding work presents an opportunity to create a higher and more useful covered space to accommodate two cars. The configuration of the boundary with Trevarth Farm is maintained, but the internal space is increased by advancing the western wall towards the house by 1.5m. The new tiled roof will be in keeping with that of the barn itself and will support an increased complement of solar PV panels.
