e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Sycamore located in front garden. Removal of deadwood. 3 metre uplift to remove the branches shown in the T1 images that overhang low across the owners driveway and graveyard of St Michael and All Angels Church. Removal branches overhanging roof of owners property as indicated in image in order to reduce debris collecting in the guttering and give some clearance between the crown of T1 and the roof. The owner is concerned about the lower branches over the graveyard as it is visited by relatives and grounds maintenance workers.

T2 - Lime tree located in front garden. Request 2 metre height reduction to previously reduced height. 3 metre uplift to remove epicormic growth and branches with pruning cuts to BS3998 where this has not been done during previous work on the tree.

T3 - Cherry, as can be seen from the image this tree has around a 70 degree lean. 90cm height reduction as indicated in the T3 image and lateral reduction of 60cm to reduce the weight but maintain balance.

G1 - 3 x Pear trees, annual pruning to reduce height by 60cm, 1.8 metre uplift and a light lateral trim to shape
