On behalf of Barclays Bank UK PLC, please find the enclosed Planning Application for the installation of bird deterrent spikes to the eaves and above the advertisement signs to the front of the branch. The branch has been subject to roosting from feral pigeons who are depositing fouling to the street and frontage of the building. This poses a slip risk to the customers and staff of the branch and passing pedestrians. The installation of the spikes will deter pigeons from alighting on the ledges and prevent waste build-up in the area.
