LOCATION: Annesley House Queens Crescent Southsea PO5 3HE

PROPOSAL: Within Tree Preservation Order 17 - (T73)(Aesculus hippocastanum) - Horse Chestnut - Removal of deadwood in crown. 2-3m lateral reduction. Crown lift to 3 metres above ground level by removing small diameter branches < 75mm; (T74)(Crataegus) - Hawthorn - Fell Tree. Tree to be replaced by one of the following: magnolia, ornamental cherry, olive or liquid amber; (T72)(Castanea sativa) - Sweet Chestnut. Crown reduction by 2-2.5m. Reduce radial branch spread by 2-2.5m with a maximum diameter of live pruning wounds <100mm. Crown clean and thin by removing deadwood; (T71)(Tilia × europaea) - European Lime Crown reduction back to previous pruning points. Crown clean by removing deadwood. Remove epicormic growth at the base. Manage ivy. (21/00089/TPO)
