Statement of Community Involvement

February 2021

1 Purpose

1.1 This Statement of Community Involvement has been written to inform community stakeholders how they can find out more and influence plans for development of the Queen Alexandra Hospital site. It sets out what Portsmouth Hospitals University NHS Trust "the Trust" has done and intends to do to involve the local community, patients and visitors and staff working on the site.

2 Background

- 2.1 The Queen Alexandra Hospital site is a large acute hospital serving a local population of South East Hampshire, Portsmouth of approximately 650,000 residents. The hospital also plays a significant part in the wider healthcare system across Hampshire and the Isle of Wight and provides services across a wide area that extends to Milford and Newhaven in the west and Bognor in the east.
- 2.2 Since its major redevelopment in 2009 the hospital site has not undergone any significant change to the way in which the site is configured. A number of schemes have been delivered within the hospital itself, however the site is faced with ever increasing demand on services arising from a growing local population and changes in the structure of the NHS.
- 2.3 In 2018 the Trust published its new strategy "Working Together" followed by a new Estate Strategy in 2019. These documents, that can be found on the Trust's website, set out how we saw the site developing of the next five years.
- 2.4 Now, in 2021, the Trust is taking forward the first key steps on this journey.

3 Planned Developments

- 3.1 A lot has changed over the last ten years and whilst the hospital still looks shiny and new there is a lot that needs to be done to keep it that way. A growing population coupled with increasing demand for acute services, including access to operating theatres and diagnostic imaging, means the Trust has got to be proactive if it is to continue to play its part in the wider healthcare system.
- 3.2 The key developments planned over the next three years are identified below:
