## **PLANNING APPLICATION: 20/01158/FUL**

Alterations, extension and conversion of existing buildings and erection of a new building (part 3/4 storey) to form 19x studio apartments with ground floor A1/A3 unit and ancillary communal facilities, with flexible consent to allow for use of the studios as a Suis-Generis 'Aparthotel' facility and/or self-contained C3 Dwellinghouses; Site Of, 52-54 Garden Street, Sheffield, S1 4BJ

As we will be aware the Coal Authority are now in receipt of additional information, submitted via e-mail on the 16 September 2020, and submitted by Mr K Pursall, Director at Eastwood & Partners.

We previously commented on this planning application in a letter to the LPA dated 27 July 2020.

Mr Pursall has now confirmed that he considers that the intrusive site investigations work carried out on adjacent site can be applied to this infill site, which comprises Phase 3 of the larger development. Mr Pursall has noted that boreholes drilled have established that no coal seams are present within 30m of the surface. He concludes that there is a sufficient thickness of competent bedrock above any potential workings such that in his professional opinion he does not consider that any further investigations or stabilisation works are necessary on this site.

On the basis of the information now submitted, and the professional opinion of the report author set out therein, we **withdraw our objection** to this planning application.
