Reasons for refusal of previous application were given as 'method of illumination and bulky form'. Informal advice was sought as to whether a smaller (less bulky) internally illuminated sign may be acceptable. Aurore Manceau replied by email to confirm that an internally illuminated signage was unlikely to be acceptable even if it was smaller in size. Advice was to change the method of illumination to external illumination, and to reduce the bulk of the sign.

Consequently, this application proposes signage that is externally illuminated, is smaller overall, with thinner individual letters.
