Hi - thanks for this; the trees are between 3 and 5m in height and similar in width. We are looking to reduce the height as needed to leave the trees all about 3m in height and 3m in width, and more uniform around the trunk.

We moved into the property about a year ago and the trees have been neglected basically, so lost shape and structure and just growing towards the light (and over the hedge into the neighbours gardens). Our aim is to preserve the quality of the trees and improve the visual appearance.
