A1 - Is a Douglas Fir Tree. We do not think it has a tree preservation order, but it is in the conservation area of Santon Downham. It is located within the garden of our private property.

We would like to apply for permission to have the tree felled. This is because the roots are beginning to push up the sleepers of the raised garden underneath the bay window to the front of the property. The root structure is also in the direct line of our sewer and drain. We are worried about future structural damage to the property and/or damage to the drainage system. The tree also stands very tall at approximately 14 metres, it is much taller than the house, it is blocking out natural sunlight and is also a concern in strong winds with it being so close to the house (4 metres approximately from the bay window).
