Wild Cherry T1 (10M high, 350mm dia.) - Leaning and 3 stemmed from 1.5 metres. Reduce limb overhanging number 14 by up to 5 metres and to a suitable growth point. Reduce overhanging laterals on number 14 side by up to 2 metres and close to boundary line.

Reasons: Overhanging branches causing a nuisance to nearby roof of garage to number 14

Ash T2 (9M high, 250mm dia.) - Remove low small limb (75mm dia.) back to crown break.

Reasons: Overhanging branches causing a nuisance to nearby roof of garage to number 14
