There is an Ash tree on my boundary edge that is growing very close to the power lines supplying thee two cottages, last year UK power networks had to come after the storm in November as we were cut off from power after another tree close to this one fell on the power line. Stuart Bradnam has visited the site and suggests that we coppice this ash tree, to allow it to regrow. I have attached a map showing the site of the tree relative to the protected wood.
