In pursuance of its powers under the abovementioned Acts and Orders, Sunderland City Council, as local planning authority, has **APPROVED** the following, namely:

Application ref: 20/02404/TPA

Proposal T36 Sycamore - Reduce all around crown by up to 2 metres.

At The Coach House Hetton Road Houghton-Le-Spring DH5 8NB

Subject to compliance with the following conditions;

- 1. No tree shown to be retained on the approved plans shall be cut down, uprooted or destroyed, nor shall any retained tree be topped or lopped other than in accordance with the approved plans and particulars, without the written approval of the Local Planning Authority. Any topping or lopping approved shall be carried out in accordance with British Standard 3998 "Tree Work", in the interests of visual amenity and to comply with policy NE3 of the CSDP.
- 2. This permission shall be for a limited period of 2 years from the date hereof and the works shall not be undertaken after the expiry of the period specified to ensure the protection of the amenity value of the tree and to comply with policy NE3 of the CSDP.
- NOTE: The public notice attached herewith announcing the commencement of the works hereby approved shall be fixed on site in a prominent position at least 7 days prior to the works being undertaken.

If you are aggrieved by the decision of this Council you are entitled to appeal to the Secretary of State in accordance with Section 78(2) of the Town and Country Planning Act 1990 by notice served within 28 days of the date of the decision.
