Silver Maple, Acer saccharinum, (T2, T3, T4, T5, T6) - Routine maintenance, remove overhanging branches over tennis courts.

Sycamore, Acer pseudoplatanus, (T7) - Fell self seeded sycamore to ground level.

Sycamore, Acer pseudoplatanus, (T8) - Remove stem growing into tennis courts fence.
