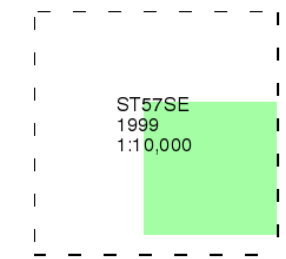

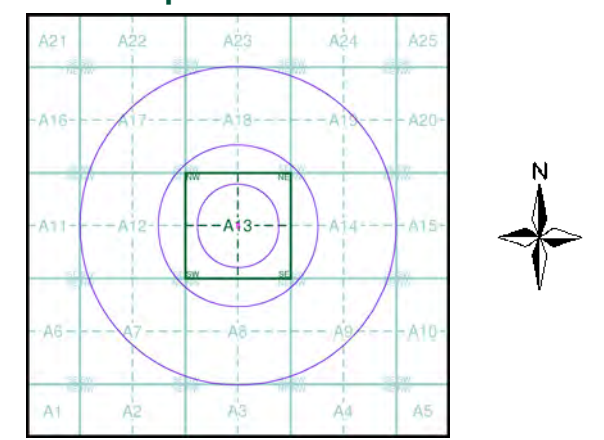

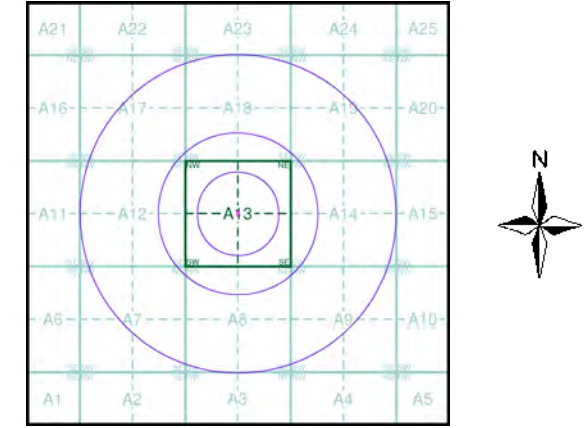

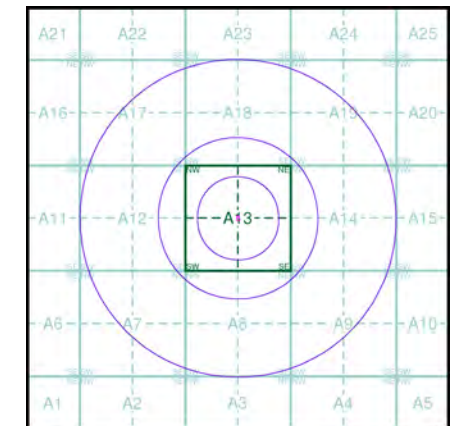

I have searched the Petroleum records held by this team and have not found any information relating to tanks past or present at this site.

That is not to say tanks have not been present and given the former site use, further investigations should be carried out.

As the petroleum licensing authority for this area we carry a limited amount of historical information about the storage of petroleum throughout the city. We took responsibility for this function from Avon Fire and Rescue Service in 2007 and ask that you bear in mind that the inherited files may not be complete.
