Gates to the front of the property which are 1.95m high. The gates are identical to those erected at 375 Woodstock Road. They are set back from the the highway by over 6.5m at their closest point. This enables a car to pull off the highway whilst waiting for the gates to be opened if closed. In addition, the ground slopes down from the highway so that the top of the gates is only approximately 1.5m above the highway.
