e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 – Oak in rear garden on south boundary
Reduce crown area by 2-2.5m all round and reshape.
Crown lift low canopy to 4m.
Remove deadwood over 30mm

T2 – Oak in central forecourt area
Option 1
Reduce lateral spread on south and western sides of crown by 3m.
Reduce remaining crown by 2m to reshape
Remove deadwood over 30mm.
Crown lift low canopy to 4m all round

T3 – Oak in north west corner of garage block
Reduce crown area by 1.5m all round and reshape.
Crown lift low canopy to 3m.
Remove deadwood over 30mm

T4 – Oak adjacent driveway on north boundary
Sever ivy at ground level and clear a 1.5m strip all round to enable inspection of buttresses
Reduce crown area by 2m all round and reshape.
Crown lift low canopy to 3m.
Remove deadwood over 30mm
