T15 Birch - prune to give 2m clearance from building - branches close to gutter.

T37 Scots pine - remove three branches - two branches on west side of stem have recently failed. Branch directly below appears weak. Pair of branches beneath join stem with a swollen compression fork and small diameter at attachment point. All three remaining branches are exposed. (see pics 4 and 5 in Treecall Report TS/64921/AC).
