REDUCTION OF THE MAIN LIMBS TO ACHIEVE AN OVERALL REDUCTION OF AROUND 60% OF TOTAL HEIGHT. GIVEN THE SPECIES IT IS EXPECTED THAT IT WILL RESPOND WELL TO THIS TYPE OF INTERVENTION WHICH IT IS HOPED WILL PROVIDE RESPITE FROM ISSUES WITH ALL SATELLITE SIGNALS UNABLE TO REACH THE HOUSE DUE TO OVERTHROW, ALSO QUOTE BLOCKAGES AND MULTIPLE COMPLAINTS FROM OTHER RESIDENTS IN THE AREA OF TREE CAUSING DAMAGE TO THE PROPERTIES GARDENS.
