The proposal is to form an enclosed Terrace Screen outdoor seating area with capacity to accommodate 6 tables and 20 chairs. We would like to create a permanent seating area outside our shop that would be enclosed by fixed terrace screens and this area to have tables and chairs. The tables and chairs will be removed from this enclosed area when the shop closes and then put out again in the morning. We would like to have 4 planters to add to this enclosed area. The terrace screens and enclosed seating area will add to the vibrancy of the area. It would help to make a nicer environment for customers on the shop front that are directed to the tables. We currently have a Street Cafe License for 3 tables but we would like to increase the seating space to accommodate 6 tables. Due to COVID-19 measures we had to remove our indoor seating area and have decided to permanently remove them as it is not safe for our clients and our staff due to the indoor space being fairly small. Hence the need for better outdoor seating area for our customers.
