T1 - (1691) - Robinia - Fell to ground level. - The tree is leaning towards NE over the neighbours garden, through phototropic growth. The tree is in poor health, large deadwood present in the upper canopy.

T2 - (1695) - Robinia - Fell to ground level - The tree is in decline with large deadwood present in the canopy.

T3 (1693) & T4 (1964) - Robinia - Reduce lateral growth over hanging the rear boundary, over Fleet Road, back to boundary, up to a height of 5.2m above ground level.
