Demolition of existing garage replace with a single side extension on the southern side of property. The extension will have a disabled wet room and living area, corridor and private entrance and be accessible from existing property. The extension will compose of a flat roof construction with a sky lantern over the living area and skylight over the wet room. The wet room will have a level access shower and comfort WC pan. The make up will compose of a block construction with smooth white render with hardwood windows and doors matching existing property. The private entrance will have a half glass door and will be wheelchair adaptable. Access routes will be step free and gentle sloping from a permeable paving parking area with disabled parking with three additional parking spaces.
