We would like to carry out the following work to preserve the health of the trees and those surrounding them. This work has been discussed with and, if permission successful, will be carried out by a qualified tree surgeon.

- T1:3 Conifer trees - top trim and tidy.
- T2:Ficus (Fig) - fell because of close proximity to Acer tree, the growth of which is being hindered by the Ficus.
- T3:Prunus (Cherry) Tree - light reduce and faceback to improve its growth and appearance
- T4:Ficus tree - fell small tree as not thriving
- T5: Pyrus (Pear) tree - 10% reduce to improve and encourage growth
- T6: Conifer tree - sited immediately adjacent to pear tree - trim to provide space and growth for pear tree
- T7: Conifer tree - fell as compromising growth of immediately adjacent pear tree
- T8: Birch tree - remove dead branch
- T9: Conifer tree - Trim top and tidy
- T10: Row of Bay trees - reduce height to level of gutter of adjacent house
- T11: Arbutus - strawberry tree - reduce height and tidy
- T12: 3 adjacent Conifer trees - reduce height and tidy
- T13: Multistem Eucalyptus tree - fell because of excessive height and damage to neighbouring property
