Crown reduce by approximately 1.5-1.8 metres in height and laterally to balance pruning to suitable growth points to retain the flowing lines of the canopy. Crown clean removing all dead, diseased, dying, crossing, rubbing and duplicate branches. Crown lift all round to a height of 3.5 metres above lawn if required. Works to be carried out to maintain the tree at suitable dimensions and in the interest of sound arboricultural practice.
