1. Holly Oak tree at the front of the house / next to the road is growing at a circa 30 degree angle so heavily leaning over the top of the drive and likely to become dangerous with continued growth. Proposal to remove top 20 feet of the tree / general tidy up.

2. Laurel tree, growing in and around power line & therefore dangerous. Proposal to cut back / away from power lines to avoid future damage
