In response to a question passed on on our behalf by Lucy Fathers:

"From a conservation perspective there are no issues with this application; it is not attached to the listed building and is at the end of the garden. The only issue possibly could be its visibility from street side, (my note - it is not visible from the street side) but given it is only a single storey and set back from street side, I don't envisage this to be an issue. It is still likely to require FPP, but I don't think it warrants a pre-app. I would check with the duty planner.
