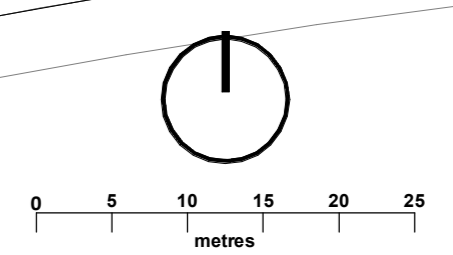

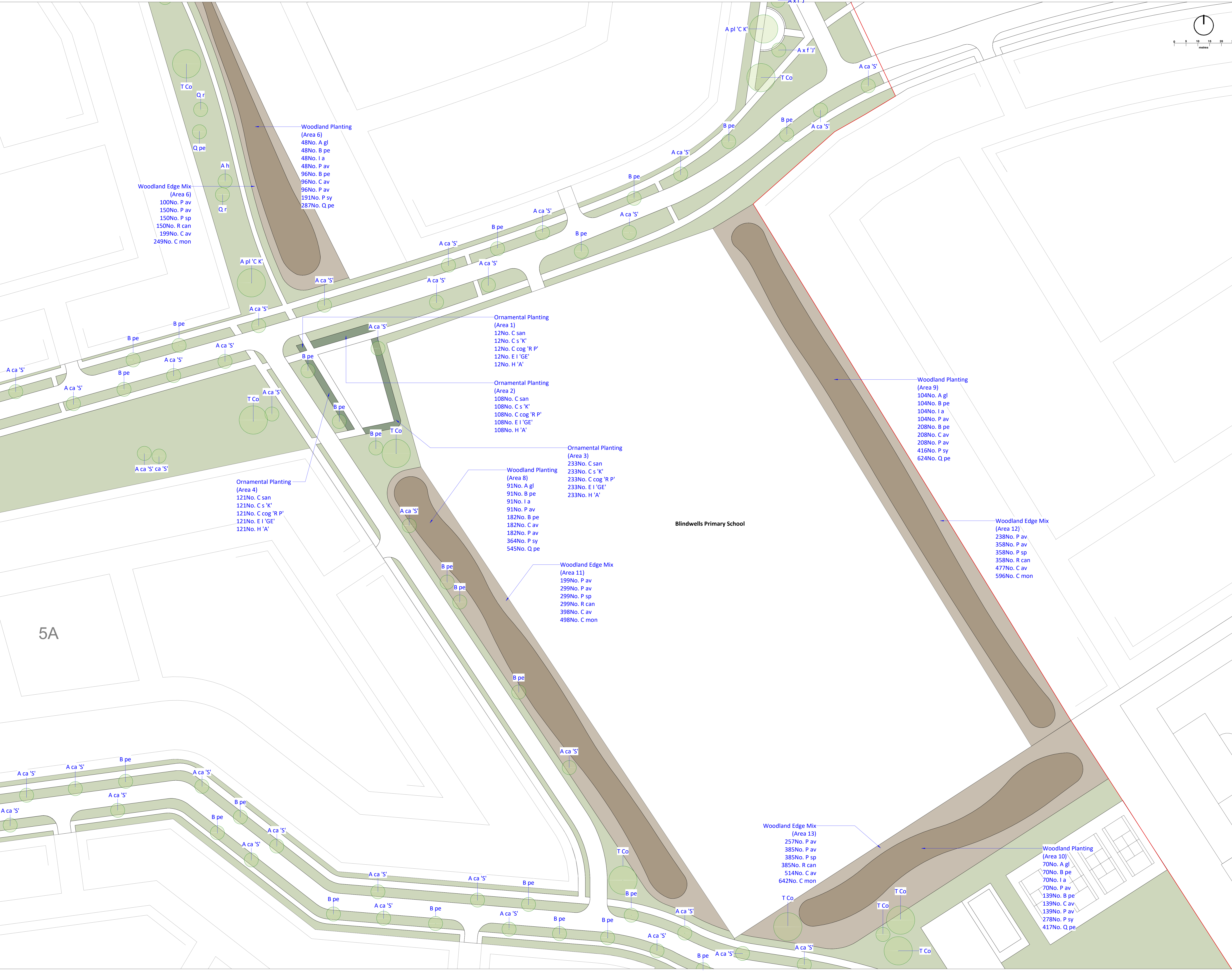
Legend

- Meadow Mix using MGS Meadow Mix by Scotia Seeds or similar, sown at the recommended rate of 3g/m²
- Basin - Seeding to sides of swales and basins using E16 Landscape and Embankment Mix by Barenbrug Ltd or similar, sown at the recommended rate of 25-50g/m²
- Grass - Coir Matting
- Proposed Trees - 100x100x1000mm topsoil
- Woodland Edge Mix - 450mm topsoil laid on 400mm subsoil
- Woodland Planting - 450mm topsoil laid on 400mm subsoil
- Princes Loch - Water Body
- Proposed Submerged Aquatic Mix - Refer to planting plans and schedule
- Proposed Marginal Planting - Refer to planting plans and schedule

Bird Breeding Season and Vegetation Removal

It is recommended that vegetation which needs to be removed is done prior to the bird breeding season. [1st March - 31st August] If this is not possible within this period, the vegetation removal should be carried out under the supervision of an Ecologist.

If birds are found to be breeding in the vegetation which needs to be removed then vegetation removal in the area surrounding the nest must be delayed until the eggs have hatched and the young birds have left the nest.
