CONTRACTUAL WORKS

Common Ash (*Fraxinus excelsior*)

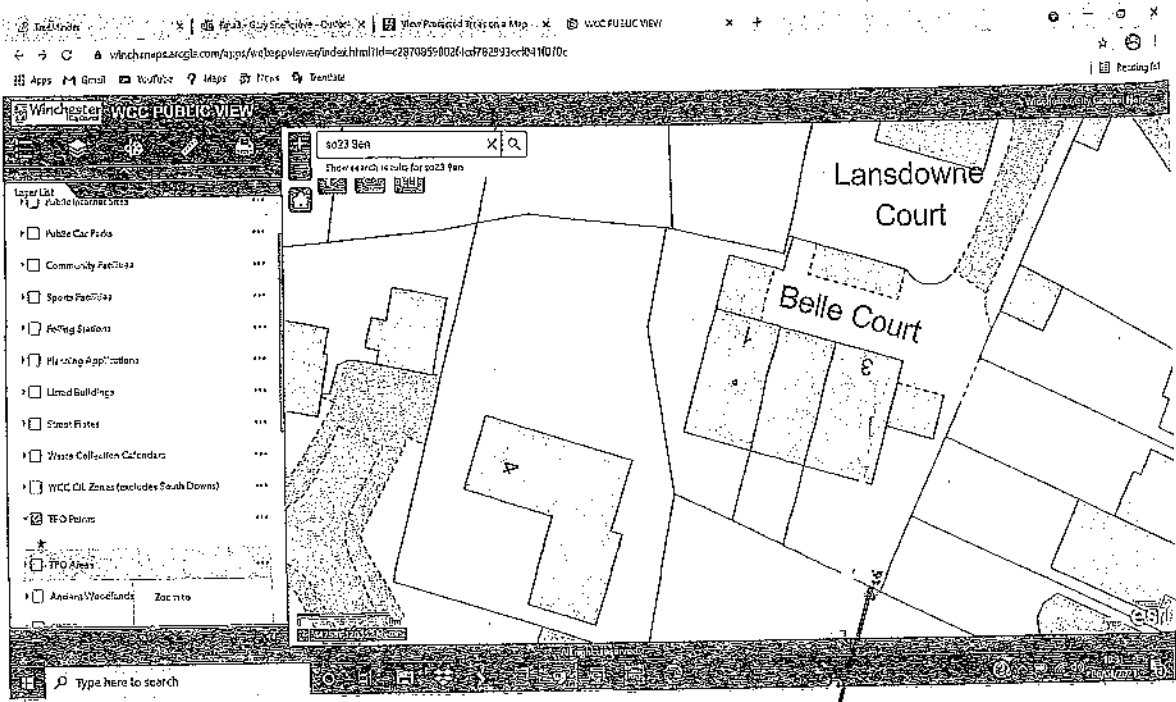
- The careful sectional removal/target pruning of the heavy 'end-loaded' limb which extends and significantly overhangs the rear of garden of No.88A, St. Cross Road.
- Risk management of deadwood.

Consultancy

- Undertake a Climbing Inspection of the remaining crown with specific reference to the historic snag which has been 'inexpertly lopped'.
- The said snag has decay evident from ground level and associated Woodpecker activity. Moreover, there is a cavity near the base of the stub at the attachment on the main trunk/stem.

Advisory Note:

- The heavy 'end-loaded' large branch represents a hazard beam, the failure of which is foreseeable. Therefore, this equates to the potential for additional work that maybe required following the above tree surgery and climbing inspection.
- I recommend that the subject Ash is re-inspected in say June or July reference Ash Dieback.
