Note: This Notification is the result of a prearranged visit by WCC Tree Officer John Bartlett to discuss options with the Applicant.

Tree 1: Taxus baccata (Common Yew)

Proposal: Raise canopy in the Southerly radius to 5 metres from ground level, to give suitable clearance over the adjacent private road (lower stem growth located above the fence to be retained and cut annually to produce hedge screen).

Remove lowest truncated primary branch located in the North Easterly radius at approx. 5 metres from ground level (approx. 2m long).

Remove adjacent primary branch also located in the North Easterly radius (approx. 5 metres long).

Remove 3 lowest secondary branches located in the Northerly radius and growing towards the roof.

Tree 2: Taxus baccata (Common Yew)

Proposal: Raise canopy in the Southerly radius to 5 metres from ground level, to give suitable clearance over the adjacent private road (lower stem growth located above the fence to be retained and cut annually to produce hedge screen).
