Mr Cunningham from Bucks Council has visited the site and seen the trees that I am requesting to have taken out, noting the way they are growing into the wire fence and twisted growth across to neighbouring property.

Remove to ground level 5 conifer tress growing along part my property boundary (trees roots are within my property) . Tree trunks have grown in a bent and twisted form and cross the boundary line. Original wire fencing in now imbedded in the tree trunks.
Tress are approx 40ft high, age unknown. Trees are blocking light to my and surrounding properties gardens and are out of proportion to the gardens around them.
Trees have low amenity value.
New tress will not be planted in their place as space is limited and the boundary will be better marked by fencing. Trees of smaller size would not make a suitable and secure boundary.
Boundary either side of the tress is made up of fencing.
