In response to your enquiry I can confirm that the fee was calculated considering the existing use of a building, which as per application form is an outbuilding and future use of a building.

As per proposal you are creating 2 new residential areas the fee was therefore calculated on 2 new developments (Cat 1) e.g.  $\pm$ 462 x2 =  $\pm$ 924. Further, because you are developing 2 new residential developments it is required to ask for Habitat Mitigation Fee  $\pm$ 50 x 2=  $\pm$ 100 to compromise for the loss of habitat.
