The previous plan was based on a development that would provide local jobs, but that has now been seen as unviable

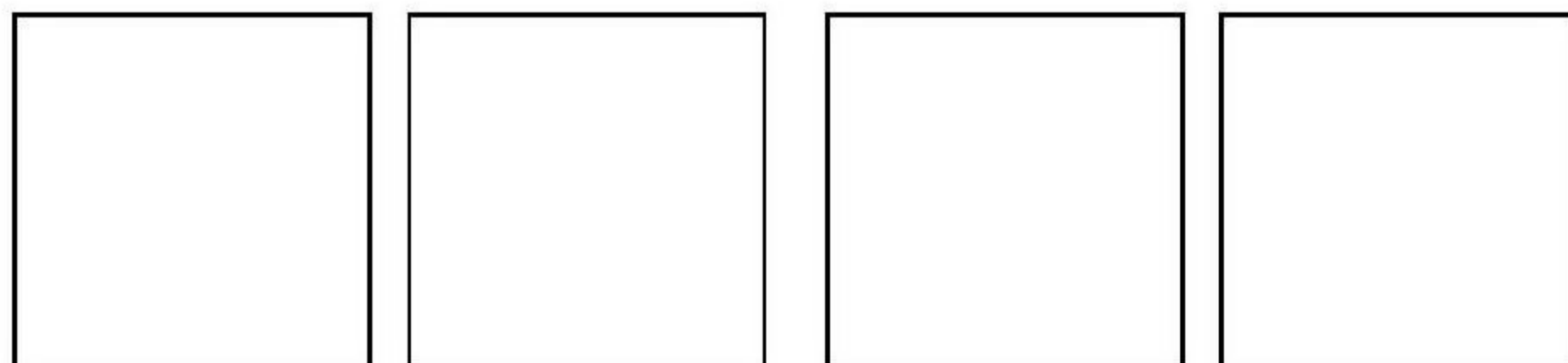

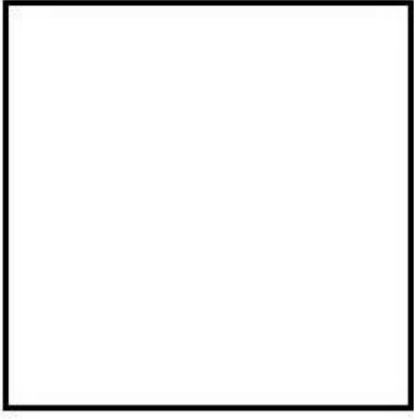
If the SDC leader really wishes to stand up for residents and the environment, this plan should also be seen as unviable.
