e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

To remove one Oak. Previous hard reduction, significant cavity, remnant fruiting body to southeast buttresses suspected to be *Laetiporus sulphureus* - Chicken of the woods. Dysfunctional structural wood on sounding. Elevated position with asymmetric rooting environment. Following removal a new Yew hedge would be provided between the existing Yews to the frontage and maintained at a future height of 1.5-2.0 metres.
