The proposed forestry building will be elevated on a concrete hard standing and will be built using traditional methods with milled wood. The walls and frame will be constructed from timber. The exterior will be vertically clad in 150mm face boards of Scottish larch from floor to roof. The roof will be bottle green (RAL 6007) and made from corrugated steel with perspex roof sheets to allow natural light in. The aim is to create a building that blends in with the natural environment.

Roof Material / Colour: * (Max 500 characters)

For the proposed building the roof will be constructed out of 1000mm wide corrugated steel sheets. The colour of the roof will be bottle green (RAL 6007) and the guttering will be grey (RAL 7016). 5 perspex roof sheets 1000mm wide will be installed at 2000mm intervals in the roof to allow natural light in to the building. The roof will be supported by timber rafters.
