- T1 Holly height 14 meters. Reduce the height by 3 meters and crown raise to 3 meters. T2 Laurel height 6 meters spread 8 meters. Reduce to 2.5 meters to create a smaller hedge. T3 Holly height 9 meters. Reduce to 2.5 meters to create a smaller hedge.

T4 - Laurel - height 3 meters. To remove.

These works are to reduce the overgrown and lapsed hedging to a more manageable height and allow the understorey to regenerate.
