

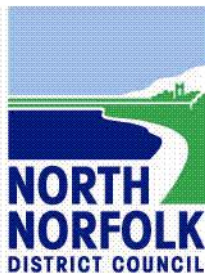

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Holly - height 14 meters. Reduce the height by 3 meters and crown raise to 3 meters.
T2 - Laurel - height 6 meters spread 8 meters. Reduce to 2.5 meters to create a smaller hedge.
T3 - Holly - height 9 meters. Reduce to 2.5 meters to create a smaller hedge.
T4 - Laurel - height 3 meters. To remove.

These works are to reduce the overgrown and lapsed hedging to a more manageable height and allow the understorey to regenerate.
