No 2 back to boundary. Estimated Crown Spread before works is 12m, & Height Spread at least 16m. Originally works recommended by SNOC Former Tree officer Tedy'n Griffith, who visited the garden at No 2, and suggested considerable reduction of spread (to 6m) and height (to 12m). However, the guidance from daughter's Paediatrician is to avoid all exposure to her including her environment to walnuts. A letter from consultant Paediatrician is attached to confirm. As mentioned above, SNOC Former Tree officer recommended significant reduction, but the letter from daughter's consultant says "No walnuts". The tree severely affects our use and enjoyment of garden with the blockage of summer day light, putting the garden into thick shade early afternoon. I didn't carry out the works in time due to personal circumstances and lack of finances.
