The trees are growing very close to the rear of the Village Hall and the drains at the rear. They heavily overhang the Village Hall and they are interfering with both the drains and the roof. These trees are semi mature Sycamore trees, likely self seeded. They will if left increase in size three fold and will cause structural damage to the Village Hall. They are growing 1-1.5m from the rear wall of the Village Hall.
