Tree 1: (T1) Bay Tree. Reduce height from 5m to 2m.

Tree 2: (T2) Holly. Reduce height from 4m to 0.5m  
Tree 3: (T3) Myrtle. Reduce height from 4m to 0.5m  
To encourage regrowth at a more beneficial height.

Hedge 1: (H1) Pittosporum. Reduce height from 3m to 2m

Tree 4: (T4) Pittosporum. Reduce height from 3.5m to 3m  
Tree 5: (T5) Pittosporum. Reduce height from 3.5m to 3m

The red line on the photographs indicates where we intend to prune back to.
