Hedge 1: (H1) Pittosporum. Reduce height from 3m to 2m		
Tree 4: (T4) Pittosporum. Reduce height from 3.5m to 3m Tree 5: (T5) Pittosporum. Reduce height from 3.5m to 3m		

The red line on the photographs indicates where we intend to prune back to.
