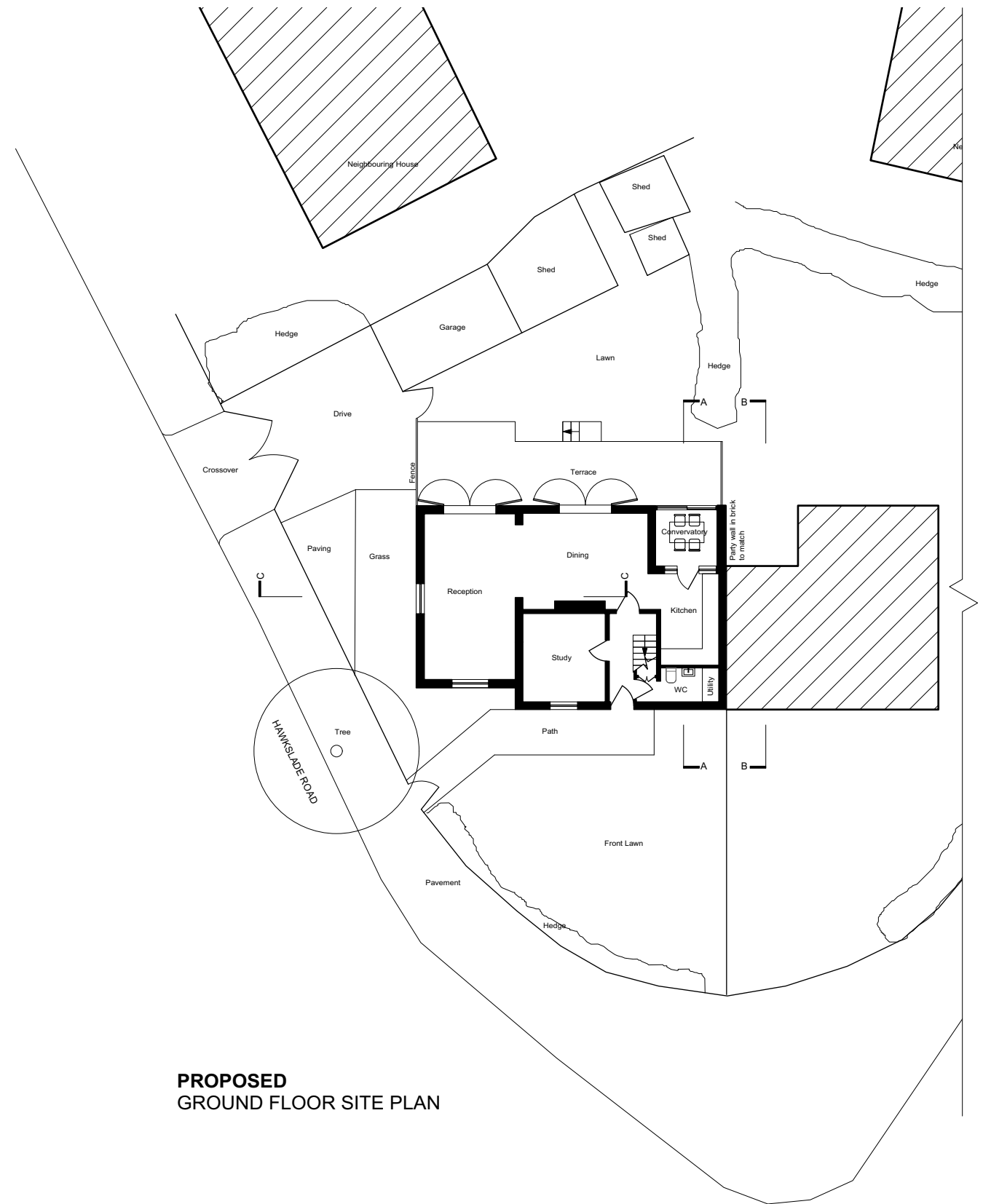

GROUND FLOOR SITE PLAN

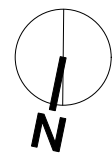


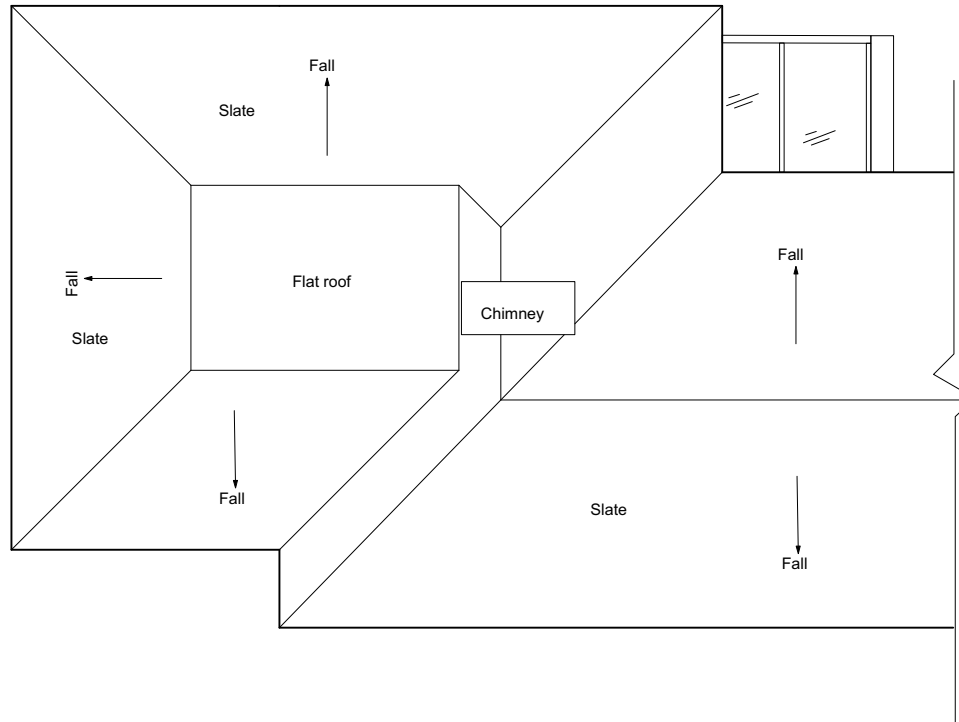

GROUND FLOOR SITE PLAN



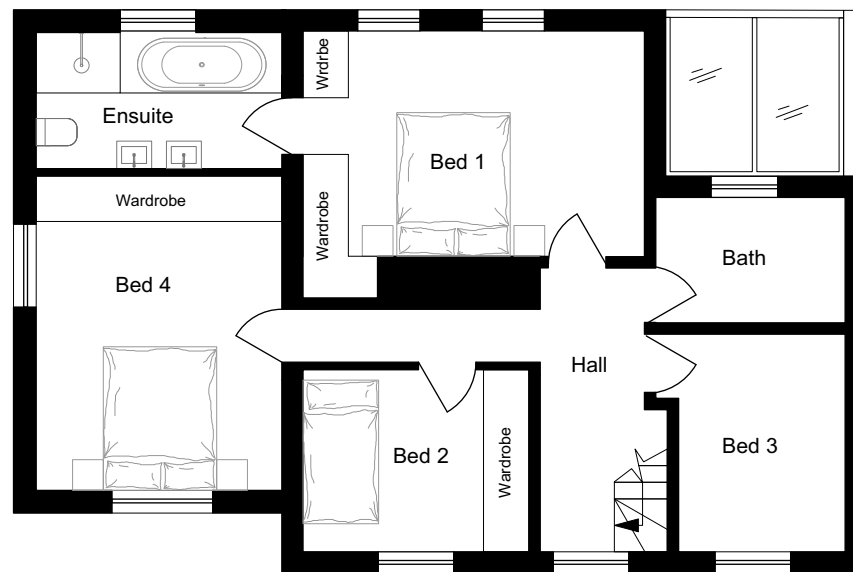

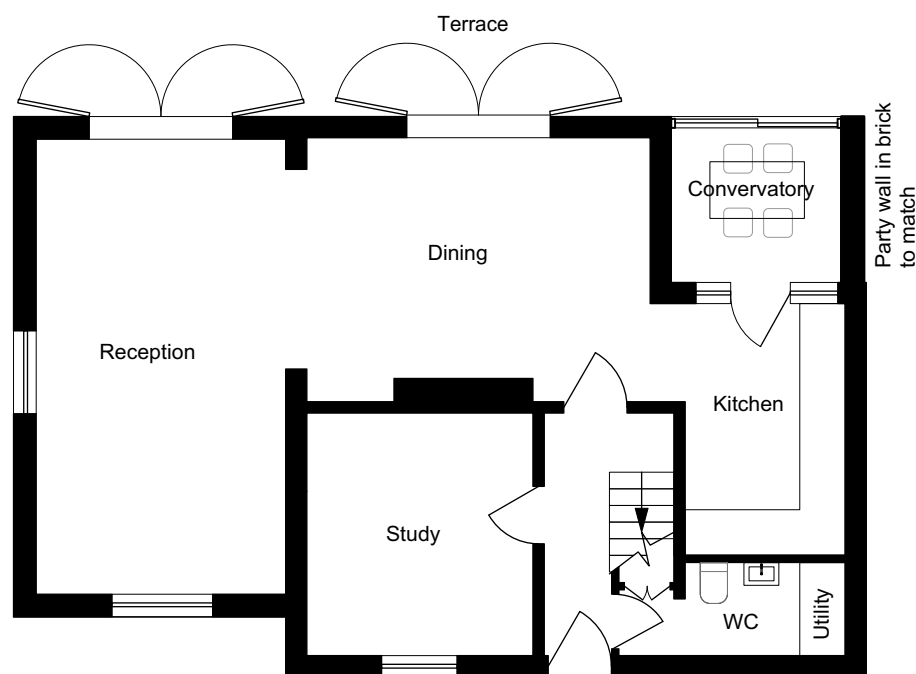

FIRST FLOOR PLAN**





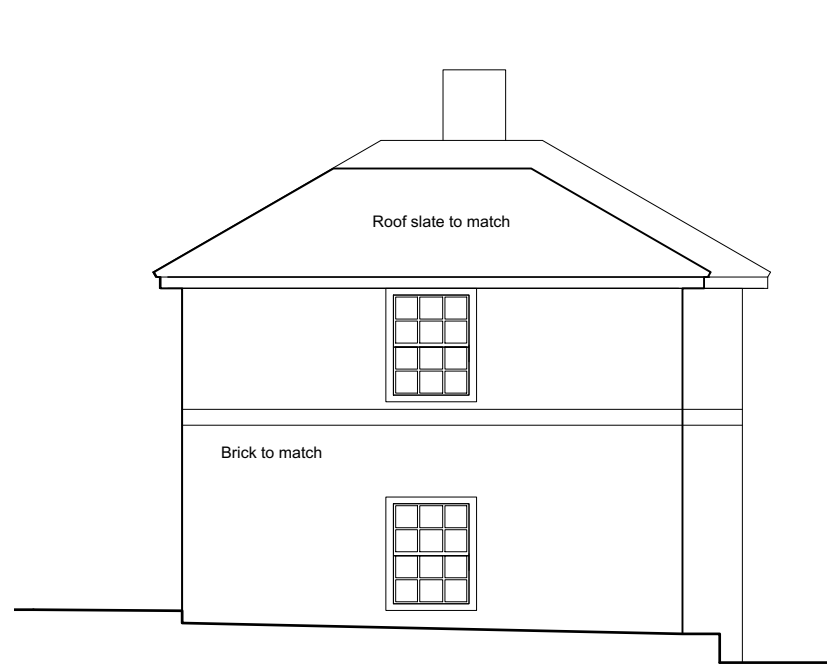

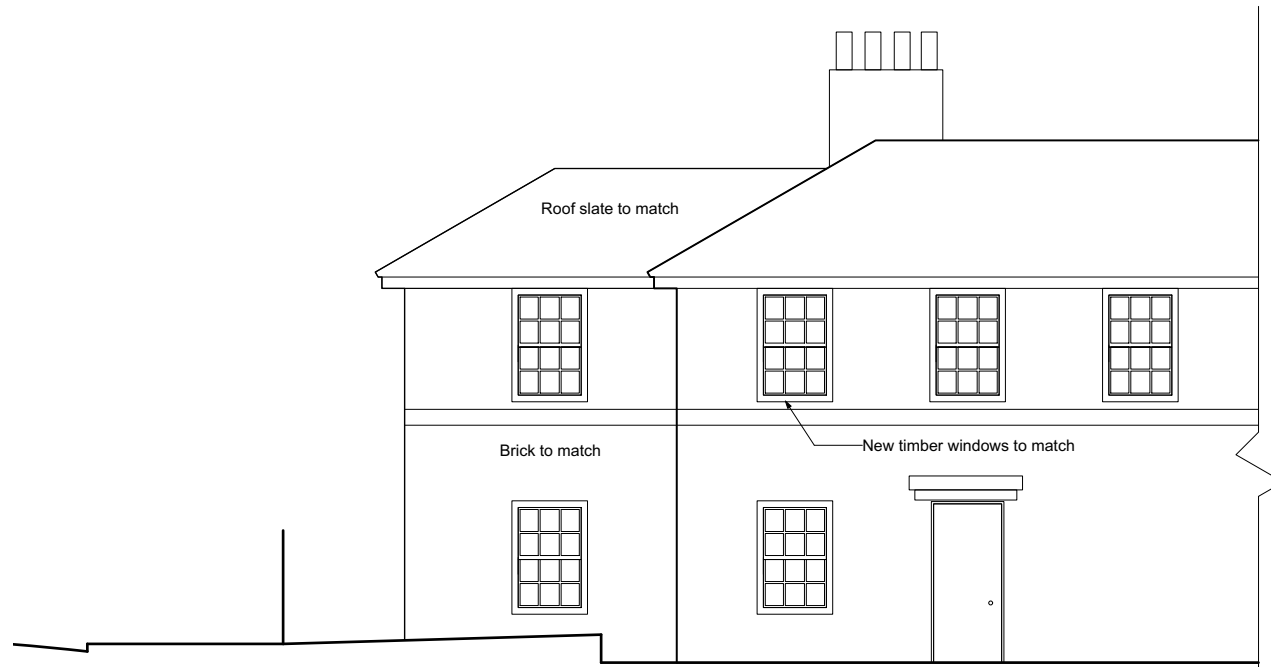

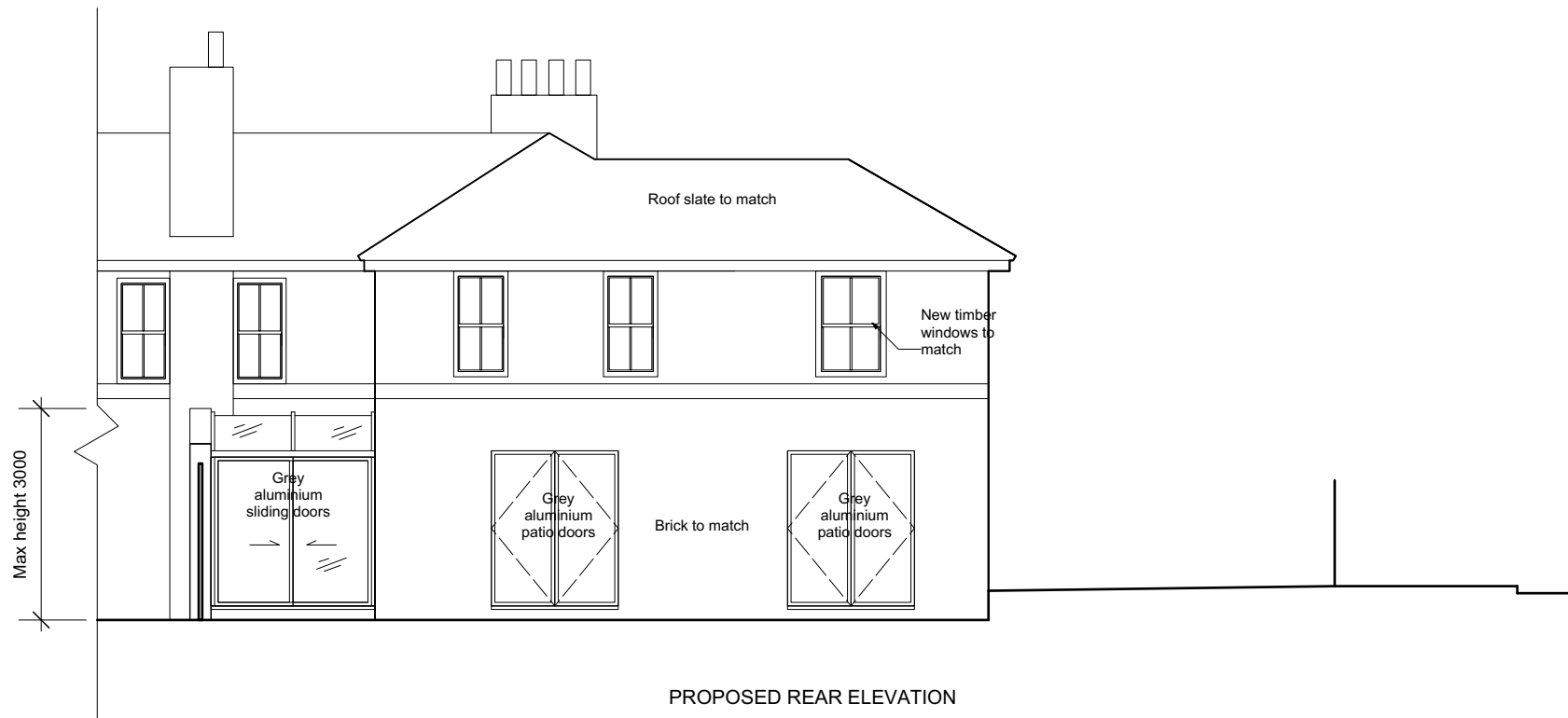

PROPOSED FRONT ELEVATION

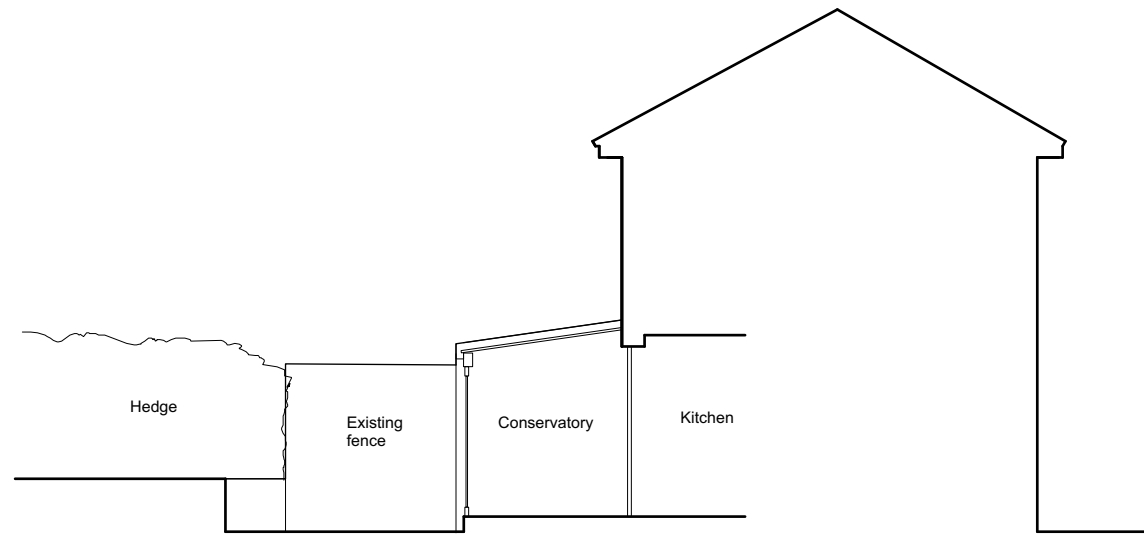


PROPOSED REAR ELEVATION

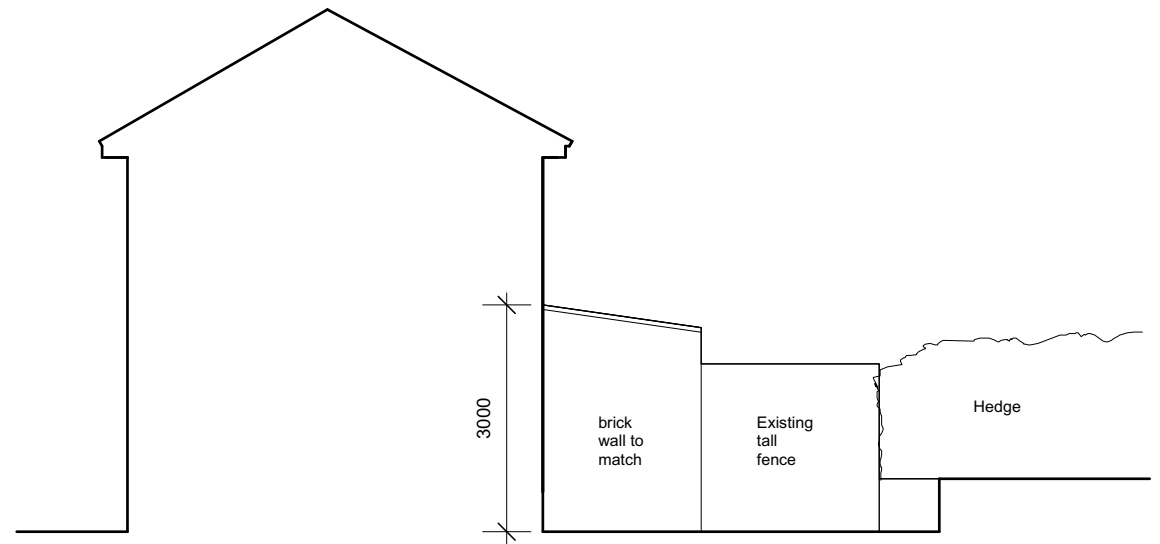

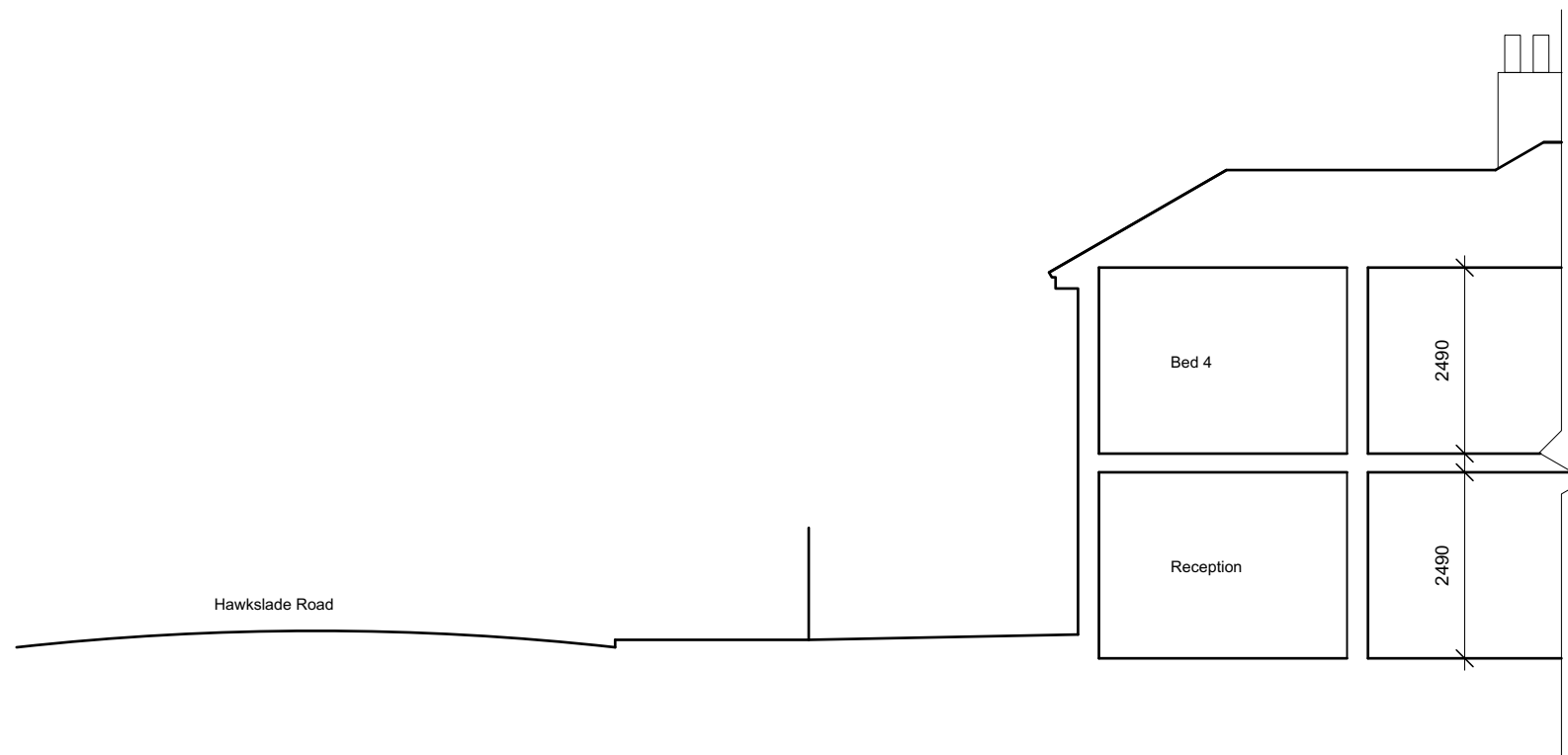

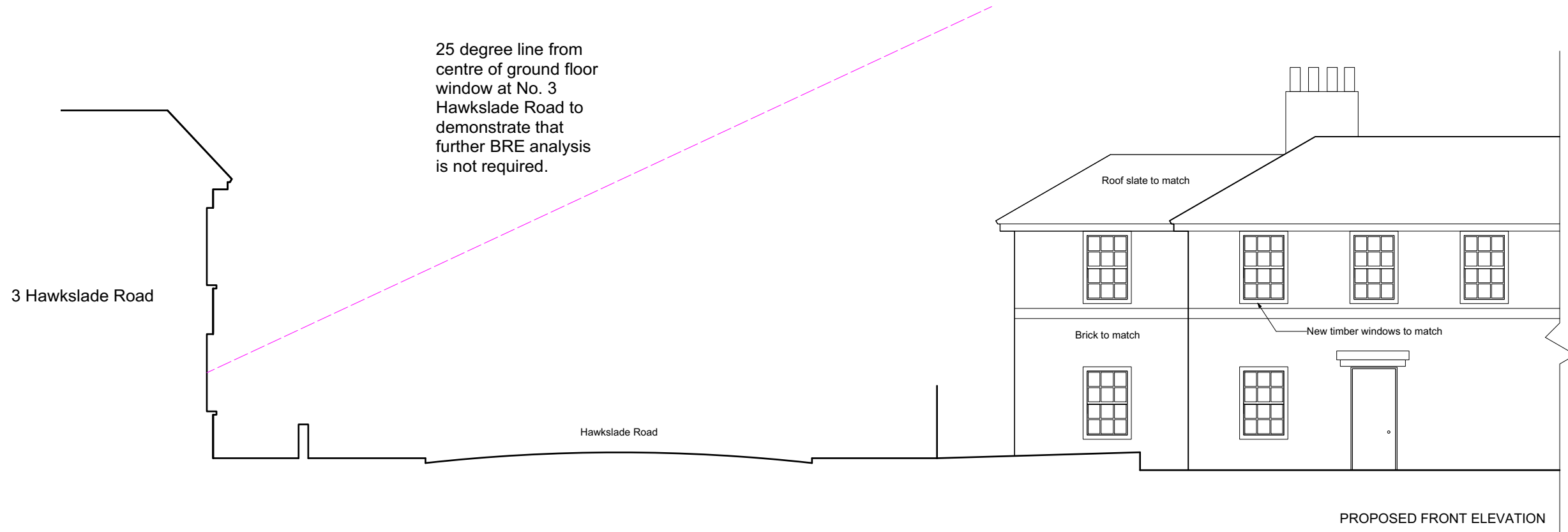
