PROPOSED BASE STATION UPGRADE AT CTIL_11758927_TF_070019_VF_19302_0, MANOR STREET, HULL, EAST YORKSHIRE, HU1 1XH (E509948 N428784)

This submission is a full planning application and is in accordance with the Electronic Communications Code (as amended) for permission for the development of:

The proposed upgrade of an existing base station comprising the proposed removal of 6 no antennas and the installation of 12 no antennas, 3 no 300mm dishes together, proposed cabinets together with ancillary development thereto.

Telefónica UK Limited has entered into an agreement with Vodafone Limited pursuant to which the two companies plan to jointly operate and manage a single network grid across the UK. These arrangements will be overseen by Cornerstone Telecommunications Infrastructure Ltd which is a joint venture company owned by Telefónica UK Limited and Vodafone Limited.
