These were in my garden when I moved into my house. Over the years they have grown extremely tall. The fence behind the trees has collapsed and I am intending to have it replaced. I would like to call in a professional tree surgeon to reduce the height of the willow from its existing 30 feet to 12-15 feet and to thin the crown and shape the tree appropriately. The plant has developed four separate trunks which are very close together and close to my neighbours wall. The Holly I would estimate at 25 feet in height and I would like this reduced to 8-10 feet. I think this would still screen the buildings behind but be more attractive and in scale with the garden as a whole. I have spoken to my neighbours at 5a, Hawthorne Mews and they are happy for this work to be done.
