Sample panels of stonework (natural and reconstituted), demonstrating the colour, texture, coursing and pointing are to be erected on site and approved in writing by the Local Planning Authority before the relevant parts of the work are commenced. The approved sample panel shall be kept on site for reference until the stonework is complete. Development shall be carried out in accordance with the agreed sample panels.

- all new external doors
- all new windows (including cill, head and reveal details)
- eaves, verges and ridges
- all new external glazed screens
- conservation rooflights
- chimneys
- all new vents, flues and external meter boxes
- coping to new boundary wall
- exterior signage rainwater goods
