Condition 11 (Acoustic Insulation) - Before the development commences a scheme for acoustically insulating the proposed residential accommodation against noise from Sale Road shall be submitted to and approved in writing by the City Council as local planning authority. There may be other actual or potential sources of noise which require consideration on or near the site, including any local commercial/industrial premises. The approved noise insulation scheme shall be completed before any of the dwelling units are occupied.

Noise survey data must include measurements taken during a rush-hour period and night time to determine the appropriate sound insulation measures necessary. The following noise criteria will be required to be achieved:

-Bedrooms (night time: 23.00 – 07.00): 30 dB LAeq (individual noise events shall not exceed 45 dB LAmax, F by more than 15 times) -Living Rooms (day time: 07.00 – 23.00): 35 dB LAeq -Gardens and terraces (daytime): 55 dB LAeq
