1. A copy of the Historic Structure Record is attached. This has been saved on the National Trust system as agreed with Susannah Homer following conversation with appointed Archaeological Consultant.
2. Sample bricks are available on site at Knole. These can be viewed against the existing structure or deposited at Sevenoaks District Council Offices. Please contact the Agent to arrange visit or delivery.
3. It shall not be possible to provide a sample of the coping bricks which are to be made in a new mould by Lambs Bricks to match the dimensions of the existing. All bricks will be manufactured in a single batch. The colour and texture will match the bricks identified in point 2 above.
4. It is hoped that the salvaged stonework from the fallen wall will be sufficient to allow for the reconstruction. Should additional stone be found to be required it will be sourced as identified on original application and a sample can be deposited prior to its use.
