Further to the works for which listed building consent was granted on 23 February 2021 (PA20/11402) we would like to:

- Install a 5kW wood burning stove and flu. The proposed location of the stove is in, what is believed to be, a historic opening for a fireplace. At some point the size of the opening was increased to allow the installation of a cooker and cooker hood. We propose to lower the existing concrete lintel over the opening so that the opening is more proportional in size to the chimney breast. A slate hearth would be installed. The flu will need to pass through the slate roof.

- Amend the location of the air source pump included in the previous application. We now propose siting the pump at the rear of the property as per the amended plans provided (PA20\_11562 - Amendment - Dec 2020 application Proposed plans 270321).
