The tree is planted on top of the properties gas mains, water pipe and drains. The path and edging is being lifted by the roots and will damage the gsrden wall. The tree was rightly described as unsuitable for its location by the surveyor when the house was purchased in 2009. However the owner did not want to take down the tree is now much larger and completely unsuitable for the garden. The tree is now obscuring the street lamp. The neighbour has to dodge the overhanging branches and has concerns about the roots damaging her own house.
