- T2 - sycamore - reduce from road by 2m and lamp post
- T3 - ash - reduce by 2 -3 M road side
- T4 - ash - reduce overextend limbs to rebalance
- T5 - Alianthus - reduce road side by 2 - 3 m
- T6 - ash - reduce road side by 2m to rebalance
- T7 - sorbus - crown thin
- T8 - ash - reduce road side by 2m to rebalance

All trees to be crown cleaned whilst working (removal of dead wood and damaged limbs)
