His details are with the London Borough of Ealing who provide transport to and from school on a daily basis. As a child with autism he is very vulnerable and a few comments have been made to him by residents/visitors to the flats behind which is why it is essential the fence is high enough for privacy.



The red line denotes the proposed fencing. All bar the bit in blue was existing fencing at 8 ft high. The blue bit is an existing brick wall which is 10ft high but will be reduced to 8ft high fencing

In Appendix 2 I attach a photo from the sales brochure; I moved in December 2020. The tree was taken down in 2 stages and badly damaged the fence necessitating replacement. The picture demonstrates the height of the fence against the existing 10-foot wall which was measured by planning officers when they came round regarding the approved extension. One of the reasons I bought the property was because of the high fence around the two open sides of the property as it provides security for me and my three children, two of whom have registered disabilities. The new fence has been supplied by Jacksons and is an acoustic fence to help dissipate noise.
