Crown clean removing all dead, diseased, dying, crossing, rubbing and duplicate branches. Crown thin by 15%. Crown lift to a height of 1.8 metres. T2 Yew; Crown clean removing all dead, diseased, dying, crossing, rubbing and duplicate branches. Crown thin by 15%. Reduce clear of building by 1.8 metres. Crown lift to a height of 1.8 metres. NG1 mixed species; Prune back to the boundary.
